

## Modern Slavery Policy Statement

Section 54 of the UK Modern Slavery Act 2015 provides consumers with information regarding manufacturers and retailers' efforts to address the issue of slavery and human trafficking. At Piramal we strive to uphold human rights in all our business activities.
